Proviso:

Should any processing problems arise, completion of the circulation takes priority over ad special processing.

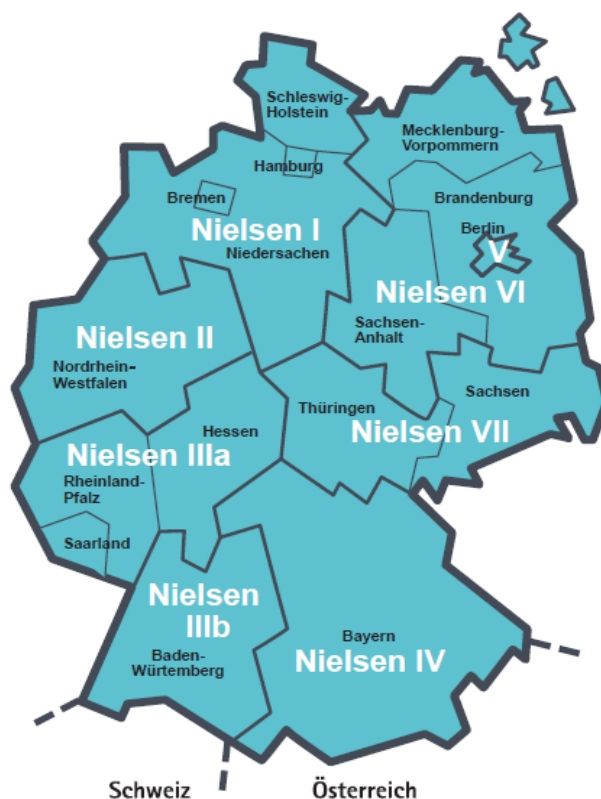
